Further, agreements concerning any programme shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing, executed by the duly authorized representatives of the parties.

This collaboration will take effect on and will be valid for **FIVE (5) Years** from the date noted in the first line of this document unless terminated by one of the parties. Either party may withdraw from this agreement provided written notification of the withdrawal is given to the other party atleast three months prior to the desired with withdrawal date. This collaboration may be renewed for another period of **FIVE (5) Years** upon mutual written consent of the parties before the expiration date. Each institution will have copies of this agreement.
