Today on 02-12-2021 both parties met in the chamber of the Party 2's office and agreed to come to a memorandum of understanding as follows.

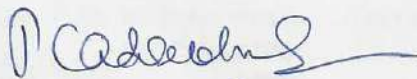

Both the parties agreed to extend their services without financial commitments.

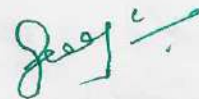
After a careful study of the above memorandum of understanding both the parties representatives signed on behalf of. It will come into force immediately.
