CLAUSE-1

CLAUSE -2

SCOPE OF THE MoU

CLAUSE 4

VALIDITY

- 4.1 This Agreement will be valid for THREE years from the date of execution of this agreement, and shall be automatically renewed thereafter for another three (3) years unless a written notice to terminate or amend this agreement is given to the other party six (6) months in advance.
- 4.2 It is expressly agreed that neither party shall be liable for damages that they Might cause each other as a result of a forceful suspension of a collaboration program.
- 4.3 Both Parties may terminate this MOU upon 30 calendar days' notice in writing.
 In the event of Termination, both parties have to discharge their obligations

CLAUSE5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act,1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Visakhapatnam.
